5. That the permission does not confer any right on the society for claiming recognition.
6. That the permission is accorded to Jeevan Jyothi Educational Society society and no other society or body can open a school on their behalf.
7. The permission is accorded to open the school premises in the locality and there shall not be any change in the premises or locality.
8. The society shall provide the necessary material even if it costs more than the deposit amount.
9. Following the NEP norms as per reference 4th read above.
